The Monash council has voted on Cr Lake's VPO proposal and the result, predictably, favoured the amendment. An in-depth analysis of this not merited here, but it is relevant to say that the process is far from over. All residents of Monash should, by now, have a copy of the proposed VPO amendments. Any interested party, and I assume that includes members of Friends of Damper Creek Reserve, should respond in writing to the:

Members of the committee have been conducting investigations to determine the most effective method of responding to the The conclusion is that the amendments. vague and unworkable nature of the amendments would be sufficient cause to disallow the amendment when it is submitted to the state planning authority.

The Committee will draft a response on behalf of the FODCR for approval by those who attend the February meeting. It should be emphasised that this should not be used as a template for the responses of individual members who should frame a response in their own words and add any concerns perceived in addition to those expressed on behalf of our group.

Another way of bringing your concerns to public attention is to write to the local papers. The VPO is a hot topic and there is a good possibility of getting your letter published. As we have seen, interest groups can easily create the impression of an overwhelming desire for change when those of the majority view remain silent. Therefore it is important to keep up a flow of letters to the local press prior to the March 15th deadline for responding to the proposal.

The Feb 12th issue of the Leader has an article on the VPO accompanied by a photo of Sally Walker of our sister organisation "Friends of Scotchman's Creek and Valley Reserve".

A Conservation Story

Not everyone has the means to save a significant piece of the environment for the future but a combination of circumstances has seen Rob McNaught, founder of Peregrine Adventures, instrumental in saving 286 hectares of the Tootgarook Swamp on the Mornington Peninsula. Rob bought the land in 2001 after environmentalists sabotaged an auction of the land by implying that permits for development would never be granted.

He began talking to "Trust for Nature" to secure a covenant over the land to prevent development, a process that stalled due to legal hurdles.

The solution to Rob's problem came from an unexpected quarter. Construction of the Peninsula Link Freeway required environmental offset to be provided for destruction of native vegetation along the freeway route. The freeway funds will finance rehabilitation of the area, removal of cattle and feral animals and protection of remnant vegetation and endangered species

This is the biggest offset covenant administered by Trust for Nature. conservation success bought about by a strange combination of "greenies" sabotaging an auction, a businessman with a love of nature and a freeway.

Exit Indian Mynahs

FODCR members have been motivated to take direct action regarding an explosion in numbers of Indian Mynahs. These birds are not native to Australia, are particularly aggressive and exclude native species from suburban gardens and bushland. Following investigations by our secretary, Maryann Hawthorn, Frank Carder and Maryann purchased a number of traps designed specifically to catch these birds. To date over 100 have been caught in these traps and humanely destroyed. The traps can only be used on private property. Benefits to the environment have already been observed as native birds are returning to trees previously occupied by these "rats of the air".
