

From the President's Desk

The tail end of 2022 concluded with the Council's press release on the decisions regarding the leash free status of Damper Creek. After much controversy the Council decided on a compromise position with portions of the reserve retaining the leash free status. There were no winners in this decision which attracted much media attention. Volumes have been written (the Community Consultation Report ran to 107 pages) with multiple meetings, newspaper articles and interviews on radio and television. Due to the diversity of opinion within the "Friends", a neutral position was adopted and media was dominated by the dog walking lobby. At a meeting between Council representatives and several members of the Friends of Damper Creek on January 30th we were assured that we would be consulted when decisions were made regarding the exact implementation of the new arrangements.

Vigilance Required #1

The January 30th meeting with Council officers highlighted a shortcoming with the Community Consultation process. "Lack of data" was cited as the reason several serious considerations were not covered in the Council's decision making process. For instance, no data was available on injuries caused by dogs off-lead, no data on dogs injured by other dogs. However, an abundance of submissions from those wishing to continue walking dogs off lead led the Council to take the compromise solution they have adopted.

Councillors at the meeting essentially put the onus on reserve users (and by implication, the Friends of Damper Creek) to report such incidents. In principle, this sounds fine but the collection of such data can be onerous.

Any incidents within the reserve, whether caused by dog on or off lead and involving actual or potential injury to dogs or people should be reported to Council and the secretary at

Vigilance Required #2

The removal of trees, particularly in the vicinity of Damper Creek, should be a concern to all members. The loss of canopy cover is a serious problem in Monash and is of particular concern in the Damper Creek area where the canopy can provide an extension to the wildlife corridor. The preservation of trees on private land is covered by the VPO. This requires a permit for the removal of trees over 10m tall. If you see a tree being removed which is covered by the VPO, you should (a) photograph the tree, (b) report the incident to the council and (c) ask that the removal be halted until assessed by the Council.

Where a development application has been made it is possible to view the arborist's report on the Council website. If the arborist recommends removal of a tree which is covered by the VPO, you can lodge an objection to the council.

- 1/\$1000 for plants to supplement Council programmes.
- 2/ \$600 for Hamilton Planters
- 3/ \$660 for weeders and weeding tubs
- 4/ \$1000 for promotional materials and neighborhood letter drop.
- 5/ \$1000 for promotional video QR linked for visitors to reserve.
- 6/ \$150 for plants for give-aways.
- 7/ \$230 for equipment to assist in water quality monitoring.
- 8/ \$360 for school promotion.
