## **Editorial : Review of Monash VPO Amendments**

The Planning Panel hearings into Monash Council's amendments were heard in the middle of June. As well as the Monash Council submission, presentations were also made by Frank Carder on behalf of FODCR, Sally Walker on behalf of FOSC&VR and a number of other interested individuals.

Council submissions were based largely on a reduction of bureaucracy and improved amenity for residents wishing to remove unwanted trees from their properties within the VPO areas. Their submission also relied heavily on the principle of "Preservation of neighbourhood character". Council contended that the replacement of mature trees with two new plantings which "will grow to become mature canopy trees with spreading crowns to the satisfaction of the responsible authority" would ultimately enhance the neighbourhood character. At a number of points in their submission Council stated their environmental objectives and subsequently dismissed any impact on the environment from the VPO changes.

The VPP requires (among other things) under the topic of "Landscaping Objectives":

"To encourage development that maintains and enhances habitat for plants and animals in locations of habitat importance" and also

"To encourage retention of mature vegetation on the site" and

"In locations of habitat importance, maintain existing habitat and provide for new habitat for plants and animals".

"The Monash Planning scheme itself warns against the erosion of the garden city

character "through loss of significant vegetation and tree canopy".

However, Council also contends that the purpose of the clause is "founded in neighbourhood character rather than environmental significance of vegetation."

Clearly, various source documents are at odds and Council is selecting those which reflect their position.

When summarising the types of objection received, one category "The ecological and environmental benefits of mature trees would not immediately be replaced by the planting of smaller trees" was responded to by the statement that "This is not the primary purpose of the VPO". In the summary against the "Strategic Assessment Guidelines" the Council states that "The amendment does not give rise to any adverse environmental effects."

The submission on behalf of FODCR was presented by Frank Carder. Frank reflected on the change to neighbourhood character that had taken place during his time in Mount Waverley and went on to explain that the environment of Damper Creek was heavily dependent on the neighbouring gardens to provide a buffer for wildlife that resided in and visited Damper Creek. Hopefully the Panel's findings will give appropriate weighting to the environmental argument.

#### **Our Annual General Meeting**

Yes, it will soon be AGM time again and we will require a new committee. Our constitution limits the tenure of several of our officers so replacements must be found. The positive aspects are that if you volunteer you will not be saddled with a lifetime job and the critical functions of our "friends" group are periodically reinvigorated. Nominations for

Secretary, Vice-president, and Treasurer have been received, we require any additional nominations and nominations for all other positions prior to the AGM.
