

# Editorial:

**Canopy Trees.** OK, I've rattled on about canopy trees the last couple of newsletters. I've been told that readers want some specific suggestions as to what they might plant to satisfy the "Canopy Tree" requirement. As an aside it should be mentioned that the watered down C125 amendments will accept a canopy tree as one that is as high as the house. This is a definition that is hard to agree with as many shrubs will grow high enough to satisfy this definition. So, I'll start off with some of the smaller trees which won't challenge foundations or sewerage pipes.

*First, the Wattles.* This is an incredibly diverse genus with members ranging from prostrate groundcovers to forest giants. Some of them have a reputation for short lives and susceptibility to insect attack. Those described here do not have that problem.

**Acacia pycnantha.** Our national floral emblem. Will grow into a well formed tree of 7m in 10 years. Like most wattles the flowering period is relatively short. Indigenous to Mount Waverley.

**Acacia implexa:** (Lightwood). An interesting tree, a little larger than A. pycnantha with pale yellow flowers. The trunk is rough, this is a feature of the tree in the same way that the rough trunk of the ironbark is attractive. Another wattle indigenous to Mount Waverley.

Acacia melanoxylon: (Blackwood). This tree is famed for the beautiful furniture timber it produces. It can grow very tall (30m) in the deep soils of east Gippsland. It is indigenous to Mount Waverley but it is unlikely to grow taller than 10m here.

Other local wattles are either shrubs or too tall for a domestic garden. Plant nurseries can help you out with any number of quite spectacular wattles, mostly from the drier areas of Australia. Note that the popular Cootamundra wattles can become weeds and are best avoided.

**Next, the Gums:** Most of the gums indigenous to the area are either potentially very large trees or are susceptible to insect attack. The following are some of the best species suitable for local gardens:

Eucalyptus radiata (Narrow Leaved Peppermint)

Eucalyptus viminalis (Ribbon gum)

#### Eucalyptus melliodora (Yellow box)

The three gums above are all potentially large trees. Their ultimate size will be determined by soil and other growth conditions such as moisture and proximity to other trees.

There are many other (non-indigenous) gumtrees suitable for the home garden, some of which are cultivated varieties of species which are normally much larger. One of the best is **Eucalyptus leucoxylon** (White Ironbark) which is available in a number of varieties of different growth habit and differing flower size and colour. Dwarf varieties are available for the Spotted gum, Sugar gum, Snowgum and the classic Red Flowering gum **(Corymbia ficifolia).** Many other gums are naturally small trees such as the mallees. Visit a native nursery such as Kuranga in Mt Evelyn or pay a visit to the Cranbourne Botanic Gardens to investigate further.

Other trees which will suit are Banksias (only **Banksia marginata** is indigenous), Casuarinas, *(Casuarina littoralis* is indigenous), Melaleucas and Tea-trees (local varieties are more shrubs than trees) and Bottlebrush (*Callistemon sieberi* is indigenous). Expand the choice to all native plants and the range of choice is considerable. Expand the choice to exotic plants and the range of acceptable plants becomes bewilderingly large. (Birds and animals don't care if a plant is indigenous or not, provided requirements for food and shelter are met, though an indigenous plant is more likely to harbour a wide range of invertebrates and may help promote an appropriate range of fungi in the soil).

For anyone planning an initial garden on a bare block there are no excuses for not planting the required number of canopy trees. Be wary if you engage a landscaper, they are likely to plant an advanced specimen which may have restricted root growth which will eventually have stability problems. Alternatively, they may plant a fast grower which produces quick results but may ultimately be too large for the site.

# Update on C125 Planning Amendment

The Friends of Damper Creek Reserve thank you for the tremendous support you have given us in working towards achieving greater protections for the creek and bushland areas in Mount Waverley under the C125 Amendment proposals.

The special meeting of Council on 3 May 2015 was attended by several FODCR members and our president John Clements gave a presentation on the 'In principle' decision changes proposed by Council (based on a draft discussed at our April meeting - this presentation will be uploaded to FoDC's website). It was encouraging to see so many people at the special meeting of Council prepared to speak up in support of the original C125 proposals, and to express their concerns regarding inappropriate development and the rapid loss of treed vegetation in Monash.

A summary of approximately forty 5 minute presentations made to the special meeting of Council will be uploaded to the Monash Council website shortly.

The C125 Amendment proposals have been somewhat modified following the public consultation process. While some important protections for the Creek Abuttal and Creek Environs zones remain unchanged, other changes such as canopy trees (now 2 not 3), building side setbacks and site coverage have been weakened. It is disappointing also to see that the original amendment proposals for greater environmental protections in other parts of Monash have been reduced or abandoned. However, the final form of C125 has not yet been set and we are concerned that the developer pressures that led to the watering down of protections that has occurred with the '*In principle*' changes may lead to even further weakening of the Amendment.

The next Council meeting will be held on <u>Monday 31 May 2016 at the Civic Centre Glen</u> <u>Waverley</u>, where a final position on Amendment C125 will be voted on. At this meeting Council will also decide on whether or not the Amendment should go to a Hearing Panel. FoDC members are encouraged to attend if you can.

Please note that Cr Stephanie Perri has now stepped down from MCCouncil as a Councillor and as Mayor as she prepares to stand for election to Chisholm at the Federal Election on 2 July.

As a guide - FoDC suggest consideration of the following in any responses to Council:

- 1. Canopy trees: retention of the original proposal for 3 canopy trees in NRZ2 and NRZ3 is highly desirable. Maintaining the green and leafy environment of the creek areas is vital not just for character retention but also to complement and assist with the sustainability of flora and fauna in the creek reserves.
- 2. Setbacks and hard surface coverage: the setbacks and site coverage restrictions originally proposed for Creek Environs are highly desirable. It is so important for the sustainability of our very narrow bushland reserves to have nearby gardens of a size that tree planting and good vegetation coverage is possible, and that extra hard surface coverage is limited so stormwater does not adversely impact further on the creeks (flooding, erosion and silt build-up).
- 3. Request a Panel Hearing: It will be important to have the original Amendment C125 proposals noted/reviewed, and the shedding of protections under the 'In Principle' decision noted/reviewed by an independent Hearing Panel with expert witnesses. We see the original Amendment proposals as having presented a compelling model of how to manage housing development in Monash to protect and improve the garden city character of the City and achieve better long-term liveability outcomes.

Councillors should be encouraged to vote for the final C125 Amendment decision to be reviewed by a Hearing Panel, as was the case with the Vegetation Protection Overlay hearing.
