

Editorial:

Spring is here again and Damper Creek is looking magnificent. I was especially delighted to see the magnificent display of flowers at the Stephensons road end of the reserve, a sight enjoyed by all who attended the September working bee. Prominent among the flowering shrubs is Olearia lirata, (Snowy Daisy bush), Indigofera australis, (Austral Indigo) and the Bulbine lily. For those who can make it to the reserve for an early morning walk, the dawn bird chorus leaves the listener in no doubt of the value of our modest patch of bush. Likewise, in the evening the frog calls are almost deafening. Frogs may be in danger worldwide but at least Damper Creek provides a valuable refuge for local species.

Harvesting of new fern growth within the Reserve

It has been observed that large amounts of new fern tips have been taken illegally from Damper Creek Reserve. All plantings in the Reserve are protected and <u>must not</u> be removed. The Monash City Council has been advised.

Red paint in Damper Creek

An extensive and very ugly spill of red/orange paint in Damper Creek was reported by many FoDC members to the Environmental Protection Authority (EPA) and the Monash City Council with the source being successfully identified. Thank you to all who took time to make these phone calls or online reports which resulted in a speedy response from the authorities.

Please note that the storm water for over 1,000 properties (close to, and from the feeder streets around Damper Creek Reserve drain into Damper Creek) sometimes resulting in unacceptable levels of pollution entering the waterway – visually obvious and extremely detrimental to river health.

All storm water outlets from your residence must be treated with care and consideration to the environment. PLEASE DO NOT wash paint, oils, chemicals or other contaminants down your storm water drains – either check with the Monash City Council Depot in Ferntree Gully Road and/or with the EPA on how best to dispose of it.

Editor's note: I spoke with the owner and contractor involved with this incident. The owner was most embarrassed but the contractor was nonplussed at the problem. He was unaware that the stormwater discharged directly into the creek and in fifteen years in the industry had never encountered a similar problem. The issue, it seems, is that the roof resurfacing industry is largely unregulated and it appears that there is little or no education provided regarding

their environmental responsibilities. The contractor was unaware of techniques that could be applied to prevent the problem.

The EPA registered and responded to the complaint quickly but unfortunately it was unable to pump out the creek as they could not gain access for their equipment in that area. They determined that the pigment was inert and could safely be allowed to settle or be flushed with normal water flows. Meanwhile walkers in the reserve were treated to a section of the creek that, for a time, was bright red. Ducks seemed to be happily feeding in this section. Rocks that have been stained red remain in that state and it is not known how long it will take for them to regain their normal appearance.

Pollution is a significant threat to waterways and incidents of discoloured stream flow are common. It may be likely that large sectors of the building industry are unaware that stormwater drains cannot be treated as sewers and this shortcoming should be notified to the EPA so appropriate education programmes can be implemented. Until this happens, it is only the vigilance of users of Damper Creek that can place pressure on the industry and its regulators. FoDC will follow up its concerns with Mr Michael Gidley, MLA, Mt Waverley.

Monash Gardens for Wildlife

The Monash City Council Sustainability Team has recently produced a new publication 'Gardens for Wildlife'. The booklet explains the importance of the natural environment and

biodiversity, details flora and fauna of the Monash region, and provides planting advice for indigenous vegetation.

The aim of this resource is to encourage residents to create indigenous gardens on their properties in an effort to increase biodiversity in Monash. Such gardens would provide greater habitat and 'stepping storeys' for wildlife through this highly urbanized landscape.


Along with this booklet, Monash Council is planning to develop a Gardens for Wildlife program. Such a program may include household visits to help residents determine what weeds exist on their property, what indigenous species could replace them and advice on starting and/or further developing their own indiaenous garden.

Household visits will be run by a volunteer site assessor who will be

trained in how to perform such a visit. Time commitment for volunteers is not likely to be more than approx. one hour for each visit, and they would only have to perform a visit if they are able to at that particular time and date. <u>Proposed subdivision of 41–43 Alvie Road & removal of significant trees: possible conflict with newly proposed Residential Zoning "Creek Environs"</u>

Recently, many concerned residents in this neighborhood responded to MCCouncil objecting to a proposal to subdivide 41 – 43 Alvie Road into three separate titles and remove 18 of 25 significant (VPO protected) trees (in an area proposed to be covered under "Creek Environs", under Amendment C125). As a result of the considerable number of objections, TPA/44432 will now go into further consultation and re-advertisement. Revised proposed planning application signage will be placed on that property (or the MCCouncil website) which will indicate a deadline for a further opportunity to provide comment to MCCouncil.

Summer is approaching – be fire ready – information for you is available from the Monash City Council website – go to http://www.monash.vic.gov.au

Monash is generally a low risk area, however the city has a number of green corridors which have required Council to develop special fire risk plans for the forthcoming bushfire season. Council regularly carries out fire clearance works by selective dead tree removal, maintaining firebreaks, reducing vegetation density and removing excessive fallen branches and dead vegetation. Fire patrols are also carried out on total fire ban days. A fire management consultant and the Metropolitan Fire Brigade conducted a review of the fire risk of the Monash bushland reserves and developed an action plan in 2003 which is annually reviewed. There are dozens of fire hydrant access points around DC Reserve and the surrounding streets.

Residents can assist in fire safety by being pro-active ie **clearing all ground fuel and mowing lawns to create an easily defendable zone around the house, **clearing all waste material from inner roof areas and guttering, ** checking and fixing the roof thoroughly for gaps and cracks, **renewing batteries in your in-house fire alarm, etc. If you see a fire or smell smoke, do not hesitate – Dial 000.
